Beginning December 17, 2024, the Cimarron Hills Fire Department (CHFD) will be accepting applications and resumes for the position of Emergency Medical Technician (EMT) (full-time). CHFD EMT positions are traditionally assigned to a "48-96" shift work schedule.

The minimum qualifications an applicant must meet at time of application are to be 18 years of age and possess a high school diploma or GED, Colorado State (or National Registry) EMT certification, and Cardiopulmonary Resuscitation (CPR). Must possess or be eligible to obtain within 30 days of hire a valid Colorado Driver's License. All required certifications and Colorado Driver's License must be maintained current throughout employment.

Selected candidates must obtain NIMS 100, 200, 700, and 800, NWCG S130/190, current NWCG Red Card-Light, and Colorado State EMT Intravenous Therapy certification, within one year of hire.

Previous ambulance transport and firefighting experience preferred.

Candidates will be required to complete an assessment process, which may include:

- Interview to include value and character exercises and judgment assessments
- Written examination
- Wildland Light Pack Test (NWCG Standard)
- EMS knowledge and skills assessment

As deemed necessary, the onsite assessment process will be held January 21-23, 2025. (*Candidates must attend all dates in- person*). Notification of acceptance to move forward in the process to assessment dates will be sent by January 8, 2025.

The assessment process may include, but is not limited to, information from the following sources:

- National Registry of Emergency Medical Technicians Job Performance Requirement Sheets for EMT
- El Paso County Prehospital EMS Practice Guidelines, Current Version
- The CHFD Position Description for EMT position, Version 11/2024

The Cimarron Hills Fire Department 2025 EMT position includes the following salary and stipends: Full- Time **\$63,597.30 - \$70,294.90**. There is possible assignment pay for holding driver, paramedic, and/or officer certifications with completion of applicable CHFD task-books.
